The listed MARS geothermal/water source equipment meets or exceeds the requirements of the Energy Star program and qualifies for the Federal tax credit for energy efficient residential products.

Effective Jan. 1, 2017, Energy Star raised efficiency levels to Tier 3. To qualify for the tax credit, a geothermal heat pump must meet the current Energy Star criteria at the date the geothermal heat pump is placed in service (consult the tax code for more information).
