

# SAFETY INFORMATION

### WARNING

- 1. Read and save these instructions. Do not operate fan unless you have read these instructions.
- 2. Unplug the fan before moving it or performing maintenance. Do not touch the fan when your hands are wet.
- 3. Those who are not qualified electricians should not disassemble, repair or rebuild the fan.
- 4. Unplug the fan when it is not in use.
- 5. DO NOT unplug the fan by pulling the power cord. Unplug by holding the plug and pulling.
- 6. DO NOT use the fan when there is damage to the power cord or plug. If the supply cord is damaged, it has to be replaced by the manufacturer, its service agent or similarly qualified persons.
- 7. DO NOT use the fan with extension cord.
- 8. DO NOT use the fan close to fires.
- 9. DO NOT insert your hand or other objects into the grille or the movable parts.
- 10. To reduce the risk of fire or electric shock, do not use this fan with any solid-state speed control device.
- 11. DO NOT use this fan outdoors, this fan is designed for indoor use only.

### CAUTION

- 1. Unplug the fan from the socket and clean it with a soft cloth.
- 2. DO NOT immerse the fan.
- 3. Fit the guard onto fan before starting up the fan.
- 4. This fan is not intended for use by people (including children) with reduced physical, sensory or mental capabilities or lack of experience and knowledge unless they have been given supervision or instruction concerning use of the fan by a person responsible for their safety. Supervise children to ensure they do not play with the fan.


# **CARE AND MAINTENANCE**

Unplug the appliance before cleaning. Don't use any water for cleaning metal surfaces. Slightly moisten a cloth and then wipe off the surfaces of the fan. In order to remove the dust from the grill, use a vacuum cleaner or remove the front grill by removing the securing screw on the edge of the grill with a screwdriver. After cleaning, remount the grill. Reinstall and tighten the screws on the edge of the grill.

# **ASSEMBLY INSTRUCTIONS**


## 1.

Remove the base from the fan head by removing the screws



## 2.

Loosen the height adjusting knob on the standing pole. Then pull the upper portion of the standing pole to the desired height and re-tighten the adjusting knob.




## 3.

Insert the spring into the bottom of the standing pole. Then attach the standing pole to the base using the screws.




## **OPERATION INSTRUCTIONS**

- 1. Place the fan on a safe, flat surface where it can not fall or be pulled by the cord.
- 2. Adjust the desired speed by rotating the switch knob at the back of fan.
- 0 Stop
- 1 Low
- 2 Medium
- 3 High




3. To adjust the angle of the fan head, loosen the two fan head knobs, tilt the fan head to the desired angle, and re-tighten the fan head knobs.

Place the fan head on top of the standing pole and secure in place using the long bolt and nut.



# LIMITED EXPRESS WARRANTY

Congratulations on purchasing your new HVAC equipment. It's been designed for long life and reliable service, and is backed by one of the strongest warranties in the industry. Your item automatically qualifies for the warranty coverage listed below, providing you keep your proof of purchase (receipt) for the equipment and meet the warranty conditions.

### LIMITED ONE (1) YEAR EXPRESS WARRANTY

Comfort-Aire warrants item to be free from defects in workmanship and materials for normal use and maintenance for one (1) year from the date of purchase by the original consumer. This Express Limited Warranty applies only when operated per Comfort-Aire installation and operating instructions for normal use

### **EXCEPTIONS**

The Limited Express Warranty does not cover normal maintenance Comfort-Aire recommends that regular inspection/ maintenance be performed at least once a season.

### CONDITIONS FOR WARRANTY COVERAGE

Item must be operated according to Comfort-Aire operating instructions included with the unit and cannot have been subjected to accident, alteration, improper repair, neglect or misuse, or an act of God (such as a flood)

- Serial numbers and/or rating plate have not been altered or removed
- Performance cannot be impaired by use of any product not authorized by Comfort-Aire, or by any adjustments or adaptations to components
- Damage has not been a result of inadequate wiring or voltage conditions, use during brown-out conditions, or circuit interruptions

### **DURATION OF WARRANTY & REGISTRATION**

The warranty begins on the date of purchase by the original consumer. The consumer must retain a receipt as proof of warranty period. Without this proof, the express warranty begins on the date of shipment from the factory

#### REMEDY PROVIDED BY THE LIMITED **EXPRESS WARRANTY**

The sole remedy under the Limited Warranty is replacement of the defective unit. Labor to diagnose and replace the defective unit is not covered by this Limited Express Warranty. If for any reason the replacement product is no longer available during the warranty period, Comfort-Aire shall have the right to allow a credit in the amount of the current suggested retail price of the product instead of providing replacement.
