



LIMITED EXPRESS WARRANTY - E7ED/E7EM, MG1E, MG2R, M5SB

Congratulations on purchasing your new HVAC equipment. It's been designed for long life and reliable service, and is backed by one of the strongest warranties in the industry. Your unit automatically qualifies for the warranty coverage listed below, providing you keep your proof of purchase (receipt) for the equipment and meet the warranty conditions.

GENERAL

This warranty is applicable to the Comfort-Aire/Century Manufactured Home Products to include E7ED/E7EM, MG1E, MG2R, M5SB, and any accessories as required, when installed as per the Installation Instructions and as per the local, state, or federal codes of your region or area.

Labor

Labor is covered for a period of one (1) year. Any labor or service charges in excess of these allowances are the responsibility of the homeowner.

PARTS

Are covered for a period of two (2) years. Comfort-Aire/Century will not pay for parts purchased in the field other than original factory parts. Replacement parts are warranted only for the balance of the original warranty period.

HEAT EXCHANGERS

Are covered for a period of ten (10) years. If a replacement heat exchanger is not available for this model furnace, Comfort-Aire/Century will issue a credit to the distributor for the heat exchanger only. The credit may be passed to the service company and then to the furnace owner, where it may be applied towards the purchase of a new Comfort-Aire/Century furnace.

CONDITIONS FOR WARRANTY COVERAGE

Comfort-Aire/Century will provide a free replacement part or component for any defective part during the warranty period. This will be handled through the authorized distributor. Comfort-Aire/Century will not be responsible for transportation, installation, and/or service charges not outlined on this document.

The following are NOT covered by the warranty:

- Normal maintenance
- Replacement of filters
- Transportation charges for replacement parts
- Any other service calls or repairs

DURATION OF WARRANTY
